

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

This project continues to enhance our housing program with the rapid re-housing of victims of domestic violence and their children who have become homeless or are at risk of becoming homeless due to domestic violence. Supportive, trauma-informed services include housing searches and application assistance, negotiations with property owners/landlords, safety planning including legal assistance with restraining orders, crisis counseling and advocacy with other social service providers. Catalyst has a demonstrated commitment to Housing First model.

Catalyst will identify families through our own programs as well as encourage referrals from our partner agencies for Rapid Re-Housing. Catalyst will provide the financial resources for families to pay for a deposit and/or 1-12 months of rental assistance. Housing will be located throughout the community in scattered sites including large and small scale rental properties. Two Advocates (1 FTE) are dedicated to coordinate entry into the program, work with our Administrative Director to administer rental costs, and deliver the majority of supportive services. Additional agency staff will assist with identifying families who are eligible for the program and assist with supportive services as needed. The target population is victims of domestic violence and their children who are homeless or at risk of becoming homeless due to the need to flee an unsafe living environment. Participants may be seeking to leave a permanent unsafe living environment or be housed in Catalyst’s emergency shelter at the time of entry into the Rapid Re-Housing Program. Participants may also be living in other area homeless shelters or other situations in which they would qualify as “homeless” under HUD definitions.

The projected outcomes for the program are to identify and house 7 families per year through our Rapid Re-Housing Program. We project that 5 out of 7 families (71%) housed through the program will remain in permanent housing after one year of entry into permanent housing.
