2. INTRODUCTIONS/AGENCY UPDATES:

Introductions were conducted and the following announcements were given:

Angie Little, Housing Authority of Butte County announced the project-based waiting list is now open and is on the Housing Authority of Butte County website. There are 4 properties being leased up.

Hilary Crosby, Safe Space announced currently working on opening up winter shelter in mid-December. Currently looking for an intake center.

Debbie Villasenor, Housing Consultant announced Butte County Behavior Health No Place Like Home round 4 project named Oleander Community Housing, located of the Esplanade in Chico, closed construction loan with multiple lenders on November 2, 2023. Construction to start soon and the anticipated completion date is the end of December 2024. There will be 15 No Place Like Home one-bedroom units and 22 combination of one bedrooms and studios for the general homeless population with a total of 37 units. The age of eligibility is 18 years of age and older. All referrals for Oleander will come from Coordinated Entry.

Yesenia Gallegos, Chico Housing Action Team (CHAT) announced Chico Housing Action Team (CHAT) just housed their first referral from 6th Street through a CHAT internal program named Second Star. CHAT recently celebrated 10 years with an event over the weekend.

Jennifer Zellers, 6th Street Center announced she is the new Program Manager replacing Emily Periera. Jennifer announced there are several events coming up with the Silent Disco being held recently. Light the Night event coming soon.

Javi Pineda, Housing Authority of Butte County announced EHV has no new vouchers available as of the September end date, with a potential re allocation of funds coming from HUD in February.

Elisa Rawlinson, Chairperson stated if there are new programs needing to the added to HMIS from agencies please give at least a month to enter the new program into HMIS. Let the lead agency know, as soon as possible, if any agency will be needing to have any new programs added to HMIS.
