Great news! The application deadline for **Round 8** of the California COVID-19 Relief Grant Program, for qualifying arts and cultural organizations, **has been extended to September 30 at 5 pm PT**. Unlike other rounds, there is no annual revenue cap for Arts and Cultural organizations in Round 8. Applications now open at this link:

More great news, **Round 9 opened on September 9, and close on September 30 at 5 pm PT**. With \$1.5 billion in funding available, there is a good chance qualifying nonprofits with annual revenues of less than \$2.5 million can receive a grant.
