
ESSER STAKEHOLDER MEETINGS



ELEMENTARY AND SECONDARY SCHOOL EMERGENCY RELIEF (ESSER) FUNDS

ESSER III funds should, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

BASES Learning Center <u>Students primarily served:</u> -Students on an IEP needing a more restrictive setting



 Come Back Butte Charter Students primarily served: -Students age 16 or over who have not completed high school



- Butte County Community School Students primarily served:
 - -Students expelled from districts
 - -Students on probation
 - -Students with attendance needs
 - -Students with behavioral or academic needs who need a smaller setting



 Table Mountain School <u>Students primarily served:</u> -Students who are detained




 Hearthstone School <u>Students primarily served:</u> -Students who want an Independent Study program



 Special Education <u>Students primarily served:</u> -Deaf & Hard of Hearing students -Students with Emotional Disturbances -Students with Moderate-Severe Disabilities / Intensive Support needs

ESSER ALLOWABLE USES

- Coordination of preparedness and response efforts
- Providing leaders with the resources necessary to address the needs of their individual schools
- Activities to address the unique needs of low-income children or students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth, including how outreach and service delivery will meet the needs of each population
- Developing systems to improve the preparedness and response efforts for COVID-19
- Planning for and coordinating for long-term closures
- Staff training/PD on sanitation and minimizing the spread of infectious disease

ESSER ALLOWABLE USES (CONTINUED)

- Purchasing supplies to sanifize and clean the facilities
- Purchasing educational technology for students
- Mental health services and supports
- Summer learning and supplemental after-school programs,
- Discretionary funds for school principals to address the needs of their individual schools
- Other activities that are necessary to maintain the operation and continuity of services in LEAs and to continuing the employment of their existing staff
